



2025 Student attendance data collection

Dear approved authority,

The 2025 Student attendance (STATS) semester 1 data collection opens in SchoolsHUB on Wednesday 18 June 2025 and closes Friday 1 August 2025.

STATS data is:

- used as one of the measurements of schooling in Australia, agreed by all state, territory and the Commonwealth Ministers of Education
- provided to ACARA for reporting purposes. This includes publishing student attendance rates on the [My School](#) website and at the national, state/territory and school sector levels in various national reports such as [National Report on Schooling in Australia](#) and the [Productivity Commission's Report on Government Services](#).

The 2025 STATS collection process includes:

1. **Semester 1** student attendance – schools must provide and declare their semester 1 data between Wednesday 18 June and Friday 1 August
2. **Term 3** student attendance – schools must provide and declare their term 3 data between Wednesday 17 September and Friday 24 October.

Attachment A – Important information about the 2025 STATS collection

Approved authority responsibilities

As an approved authority, you must ensure:

- Semester 1 and term 3 data is submitted for all school locations within their authority by the appropriate due dates and according to the [STATS Collection Data Technical Specification](#)
- your school(s) know how to provide their data to the collection
- your school location(s) in scope for the STATS 2025 are included in your submission
- you have advised your school(s) of their responsibilities for the STATS collection. This may include schools providing you data for uploading, or you directing your schools to upload data directly to SchoolsHUB
- you have advised the Department of Education of any changes of circumstances in your location(s)
- you and your school(s) have appropriate access to SchoolsHUB to submit and/or declare data.

About the STATS collection

STATS collects student attendance rate data for full-time students enrolled in years 1 through to 10 in primary, secondary and special schools (including ungraded students within the typical age group of students in Years 1 through to 10).

Student attendance data is collected by reference period (semester 1 and term 3) and by the following cohorts at each location (campus):

- All students (including Indigenous students), by year level and gender.
- Indigenous students, by year level and gender.

Schools are required to complete STATS for each of their locations as part of their obligations under the [Australian Education Act 2013](#) and the [Australian Education Regulations 2023](#).
